PARTICIPANT AGREES THAT THIS IS A RELEASE OF LIABILITY, A WAIVER OF THE PARTICIPANT'S LEGAL RIGHT TO COLLECT DAMAGES IN THE EVENT OF INJURY, DEATH OR PROPERTY DAMAGE AND A CONTRACT BETWEEN PARTICIPANT AND LWC AND EMPOWER U INSTRUCTORS, AND PARTICIPANT SIGNS IT OF HIS/HER OWN FREE WILL.
